

## **The City of Raymond Announces Grant Assistance for Small Businesses and Non-Profit Organizations affected by the COVID-19 Pandemic**

The City of Raymond is happy to announce grant assistance for small businesses and non-profit organizations affected by the COVID-19 pandemic. These grants will be allocated from the City's portion of the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

### **Grant Award Amounts**

- Up to \$1,000 per small business or non-profit organization.

### **Grant Eligibility Requirements (must meet all requirements to qualify)**

- Your business must be physically located within the City limits of Raymond and have been issued a 2020 City Business License.  
*(businesses located outside the physical borders of the City limits are not eligible for this grant)*
- As of March 1, 2020, your business must employ no more than (10) people  
*(volunteer-based non-profit organizations are also eligible, up to 20 volunteers)*
- Your small business/non-profit organization must have been negatively affected by the COVID-19 pandemic
- You must provide a completed/signed Form W-9 with your grant application.

### **Application Evaluation Criteria**

Grant applications will be evaluated and awarded based on the following priority structure, with the heaviest emphasis placed on applications received within "Priority #1". Within each of these four priorities, completed applications will be considered in the order in which they are received.

- Priority #1: Non-profit organizations and small businesses that:
  - have NOT received other financial assistance related to COVID-19; and
  - are NOT waiting to receive any previously-applied-for financial assistance; and
  - ARE in danger of closing due to COVID-19; and/or
  - \*are NOT able to fulfill their organizational mission/duties *(applicable to non-profits only)*.
- Priority #2: Non-profit organizations and small businesses that:
  - have NOT received other financial assistance related to COVID-19; and
  - are NOT waiting to receive any previously-applied-for financial assistance; and
  - are NOT in danger of closing due to COVID-19.

- Priority #3: Non-profit organizations and small businesses that:
  - HAVE received other financial assistance related to COVID-19 (and/or may be waiting to receive any previously-applied-for financial assistance); and
  - ARE in danger of closing due to COVID-19; and/or
  - \*are NOT able to fulfill their organizational mission/duties (*applicable to non-profits only*).
- Priority #4: Non-profit organizations and small businesses that:
  - HAVE received other financial assistance related to COVID-19 (and/or may be waiting to receive any previously-applied-for financial assistance); and
  - are NOT in danger of closing due to COVID-19.

Grant applications are due and will be reviewed by the Mayor and review team.
