

ORDINANCE NO. 1881

**AN ORDINANCE OF THE CITY OF RAYMOND, WASHINGTON,
ADOPTING THE BUDGET FOR THE FISCAL YEAR ENDING
DECEMBER 31, 2019.**

WHEREAS, the Mayor of the City of Raymond, Washington completed and placed on file with the City Clerk a proposed budget and estimate of the amount of the moneys required to meet the public expenses, bond retirement and interest, reserve funds and expenses of the City of Raymond for the fiscal year ending December 31, 2019; and

WHEREAS, a notice was published that the Council would meet on the 3RD day of December, 2018 at the hour of 6:00 PM in the Council Chambers at 230 Second Street for the purpose of making and adopting a budget for said fiscal year and giving taxpayers within the limits of Raymond an opportunity to be heard upon said budget; and

WHEREAS, the proposed budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the City of Raymond for the purposes set forth in said budget, and the estimated expenditures set forth are all necessary to carry on the government of Raymond for the fiscal year 2019 and are sufficient to meet the various needs of Raymond during the fiscal year;

NOW THEREFORE, the City Council of the City of Raymond, Washington do ordain as follows:

SECTION I. That the City of Raymond, with a population below 10,000, requires a regular levy in the amount of **\$483,700** which includes an increase in property tax revenue in the amount of **1% (one percent)** from the previous year and has so been stated in **Ordinance No. 1877**, passed on the **5th day of November 2018**.

SECTION II. The budget for the City of Raymond, Washington, for the year 2019 is hereby adopted at the fund level in its final form and content as set forth in Exhibit A attached hereto, three copies of which are on file in the Office of the Clerk.

SECTION III. Estimated resources for each separate fund of the City of Raymond, and aggregate expenditures for all such funds for the year 2019 are set forth in a summary form below, and are hereby appropriated for expenditure at the fund level during the year 2019 as set forth in Exhibit A.
